# 2023 Administrative Policy Updates

Fargo Public Schools is a <u>Policy Governance</u> school district. The Fargo Board of Education adheres to Governance Process, Board-Superintendent Relationship and Executive Limitations policies to do Board work and collaborate with administration. Through the policy governance model, there is a clear distinction between Board and Superintendent roles. The primary function of the Board is to establish the policies by which the schools are to be administered, but the administration of the educational program and the conduct of school business is at the discretion of the superintendent of schools.

Thusly, administration then sets the <u>FPS Administrative Policies</u> for the operations of the district. Around 150 policies exist in the categories of Business Policies, Community Policies, Instruction Policies, Personnel Policies, and Student Policies.

Each summer, administration conducts an Administrative Policy review. FPS policies are reviewed on a set rotation, ensuring all policies are reviewed once in a four-year cycle. With the set rotation, administration reviews approximately a quarter of the administrative policies annually. Through this review process, some policies are simply reviewed while other policies receive minor updates or more substantial updates.

The policies reviewed during the summer of 2023 are listed below along with a short overview of the changes made. This year, two policies were removed from the policy book and two new policies were added. The policies added are AP 5061 Workplace Bullying Policy and AP 6523 Suicide Prevention.

# Administrative Policy Review & Updates 2023

# AP 3221 School Lunch Account Policy

Policy updated to comply with new ND legislation, added links to federal regulations, and changed the threshold at which secondary students are allowed to purchase a la carte items when a negative balance exists

# AP 3225 Food Allergy Policy

Policy updated to simplify language on school adults who should be aware of a student's allergy

# AP 3250 Wellness Policy

Policy updated for air quality impacts for outside activities, recess and extra-curriculars; the prohibition of families of bringing outside snacks for birthdays or celebrations; and general wordsmithing

# AP 3509 Theater Use Policy

Policy updated to add Bluestem Center for the Arts Amphitheater to the facility listing, remove unused definitions section, and minor word editing

# AP 3510 Community Use of School Facilities

Policy updated to move Government entities to Category 1, correct district fund noted for activity fundraising and credit card processing fee, listing of Federal holidays to all those the District is closed, and process for rescheduling due to closure on inclement weather days

# AP 3511 Renting, Borrowing, Lending or Leasing of School Owned Equipment *Policy updated to reflect correct name of the Fargo Park District and use of pronouns*

#### AP 4210 Virtual Instruction

Policy updated to align with changes to state law, remove reference to "Virtual Academies," and updated to align to procedures of enrolling in the FPS Virtual Academy

# AP 4250 Selection of Instructional Material

Policy updated for correct personnel titles, removal of confusing text, and updating references to "working days" to "student contact days" on the number of days for processing requests to reconsider instructional or library materials

# AP 4265 Student Use of Fargo Public Schools Technology

Policy title updated from 'Student Use of FPS Information Network' and policy point added regarding bypassing the District's security and web filtering protocols

# AP 4270 Religious Beliefs and Customs

Policy updated to add NDCC reference at the bottom of the policy

# AP 4275 Patriotic Exercises

Policy updated for NDCC language at the bottom of the policy

# AP 4410 Field Trips

Policy updated for minor word edits

Policy updated to include information on medical cannabis and include a NDCC reference at the bottom of the policy

Policy updated to change references of Human Resources to Human Capital, pronoun usage, and general language updates to make the policy easier to read and to clarify language that has been confusing to staff in the past

Policy updated to change references of Human Resources to Human Capital

# AP 5125 Remote/Telework Policy

Policy updated to change references of Human Resources to Human Capital, include remote workers, and include a cabinet level supervisor having final approval of remote/telework agreements

Policy updated to include information on medical cannabis and include a NDCC reference at the bottom of the policy

# AP 5160 Duty of Employees to Report Arrest

Policy updated for general language revisions
