Tax Increment Financing Notice for a Parking Garage	The Committee discussed the Tax Increment Financing Notice dated November 21, 2023, for a property tax incentive for more than five years for a parking ramp that will be built adjacent to the new community theater and apartments. Chair Jim Johnson gave some historical background on TIF projects, Renaissance Zones, and pilots and the rationale for Districts to weigh in. The Fargo School Board has not historically weighed in on these matters. Committee discussion was had on the process and the project. Consensus was that the Board will stick with precedent and will not respond or protest.	No action will be taken.
